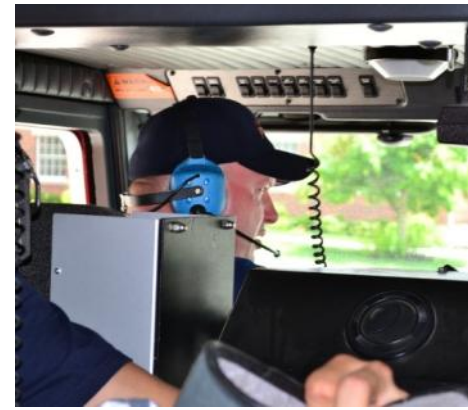

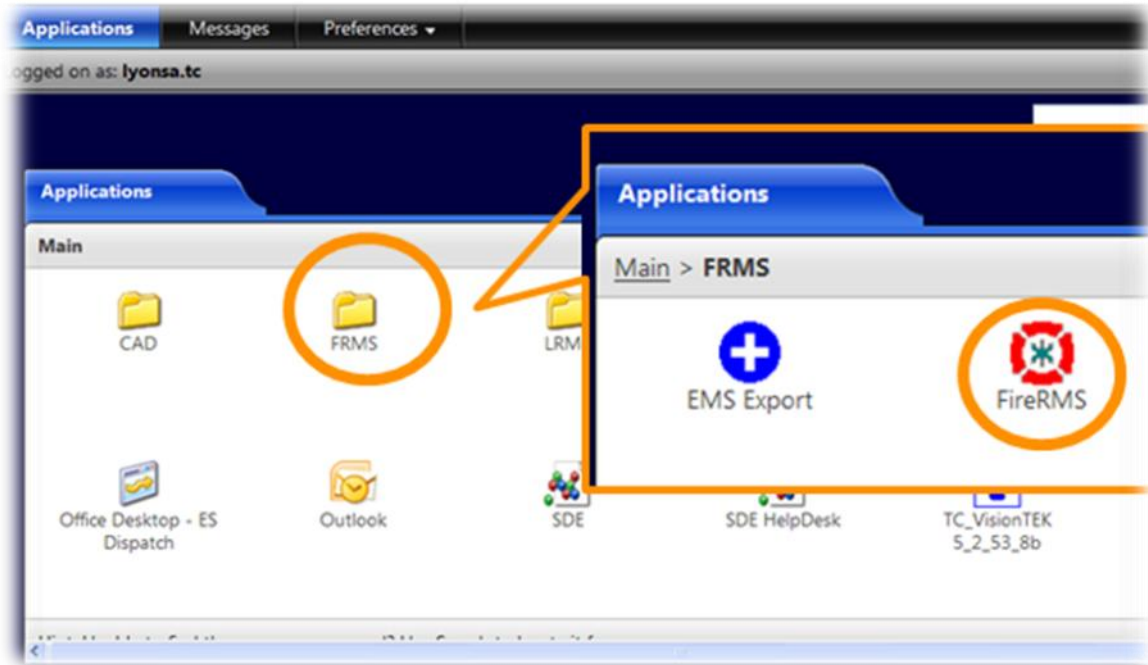

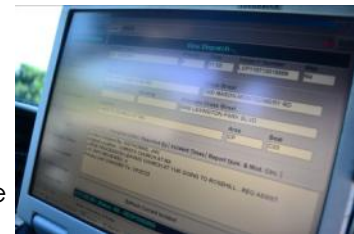

## VisionTEK Mobile CAD Capabilities @ Your Fingertips!

- In lieu of calling Inquiry, *log yourself in & out of CAD*, letting Dispatch know you're an available or unavailable unit.
- *View Dispatches assigned to you* - see Incident Type, Priority, Initiate Time, Incident Number, Map Page, Address, Cross Streets, etc.
- *Status Change* (Responding, Cancel Checks, Fuel Stop)
- *Create New Incidents (Law Only)* without calling into Dispatch - if the plate and plate state are used when creating a new incident, VisionTEK automatically runs the plate through Wants & Warrants & returns data.
- *View Incident Details*
  - Comments - added to incident by you and Dispatch
  - Assigned Units - up to 5 units
  - Reported By - Name, Address, Phone Number of complainant along with if they can be contacted
  - Incident Times - Received, Dispatched, Enroute, Arrived, Cleared
  - Report Number - the number talked about on page 4 of this SafetyNet issue.
- *Update Incident fields* rather than relaying the information for Dispatch to enter - Incident Type, Address, Building, Disposition, Comments, Report Number
- *Male/Female Transport* - you can input your destination, related Incident Number, mileage, and comments.
- *CAD Messaging* (different from VisionTEK Messaging Component)
- *Query* CAD incident information for your agency within a date and time range.
- *Request Unit Information* (History).



## “Can you fix my report number?”

The anatomy of LRMS report numbers has been explained many times (including April's Issue of SafetyNet - see illustration).

When I receive requests to “fix” or “change” a report number, I CAN - but ONLY when the format is correct. If you learn what each character in the report number means, you won't have the typical problems or complaints I hear - “The number is too long to remember,” “If I knew I had to type all of it in I wouldn't have just entered the last six,” “You know my agency so I don't need the letters,” etc. The simple fact is that I need all of the characters. WHY? TO RUN A SEARCH AND FIND YOUR REPORTS : Reports numbers are queried for various reasons: background checks, to print out for a citizen, or for your follow-up. It is easier to look up a report if the correct format has been followed. For example in LRMS (Law Records Management System), a query can be done by the date as shown below:

Using this scenario, all LSO reports done in August 2011 will appear. This also helps when a name or address cannot be recalled by the officer. Getting a quick glance of what was done on a particular day, a report can quickly be found.

These reports numbers may cause you trouble when you have to rely on your recollection to find them.

If your agency is using FBR, using the EXPORT button will greatly reduce the amount of incorrect report numbers that are manually entered. When you are viewing your dispatch on the MDC hit the EXPORT button. If you decide later that a report does not need to be entered you have wasted maybe 2 seconds of your time verses the 2-3 minutes it will take for you to recall the report and manually type in the number.

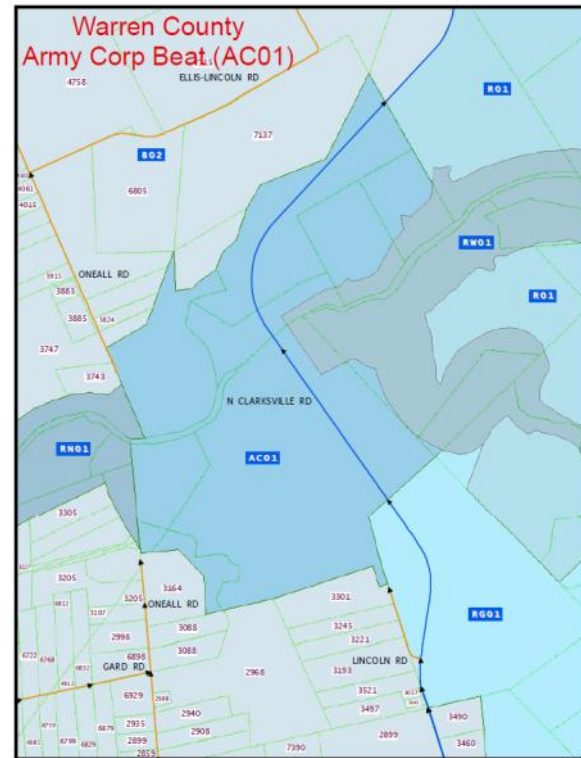

## US Army Corps of Engineers Joins Warren County Radio System



After a jolting lightning strike wiped out the Corps of Engineers' previous radio system, it made sense to link them into Warren County's system since they mutual aid on the Caesar Creek grounds. The department will have 16 portable radios shared between Park Rangers and maintenance workers, with access to all primary channels, their own Army Corps talkgroup, and those pertinent talkgroups in their geographical proximity for mutual aid purposes.

## Taller EOC Tower to be Dismantled

Ever wonder why two towers sit side-by-side at Telecom's office? The initial reason: a proposed building expansion called for the taller sibling to be replaced by its shorter, 180-foot, stand-alone brother. Although that building expansion is no more, efforts have been ongoing to transfer all functionality of the 300-foot tower to its smaller counterpart. Until now, the shorter tower was used as a microwave link to both Hatfield and Zoar Towers. Dismantling begins this month by an outside contractor.

### Benefits of dismantling the 300-foot Giant

- Save money - Any tower over 200 feet above ground level must have marker lights. This 24/7 light comes at a hefty cost which will be eliminated.
- Safer flying - one less obstacle high in the sky.
- Aesthetics - no more wires and anchor points scattered around the court building, creating obstacles and more maintenance points.
- Best of all, no more wires on which for birds to perch - should mean fewer bird droppings on everyone's vehicles.

## Hurricane Remembrance - We aren't Immune!

On Sunday September 14<sup>th</sup>, 2008 the winds from Hurricane Ike ripped through Warren County reeking havoc. All jurisdictions were impacted at some level - numerous citizens were using generators for power, people in the rural areas relied on small camp fires after the winds had gone. Warren County Fire, EMS, Law Enforcement and Public Works spent long hours, and even days, working to repair the County. Where additional help was needed to clean up debris, The Southern Baptist Disaster Relief stepped in. Warren County Emergency Management utilized the County E.O.C. after the storm for a field office for FEMA personnel. Warren County EMA was instrumental in coordinating the process with the State EMA and FEMA offices, helping the County's jurisdictions (Townships, Villages and Cities) recoup well over a million dollars.

Avoid recontamination - use a clean paper towel to turn off the faucet and open the door.

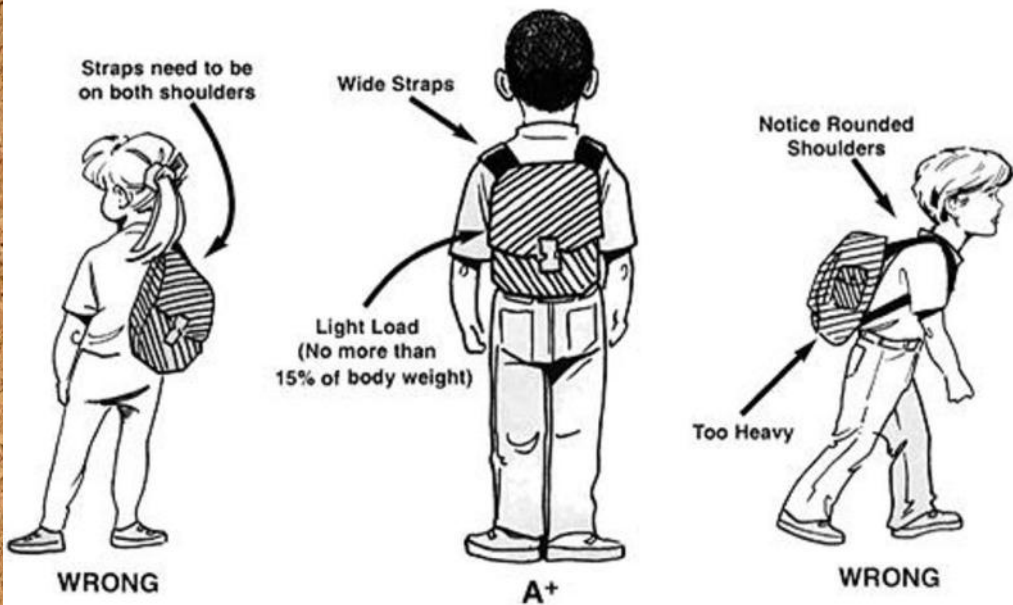
