

Clermont County Joins MARCS IP


On May 11th & 12th, Clermont County Public Safety Agencies switched to MARCS IP, joining us & other Counties that use MATACs. This gets our region one step closer to same-system interoperability!

Hamilton Twp PD, Hamilton Twp Fire, Harlan Twp Fire, Deerfield Twp Fire, and Salem-Morrow Twp Fire have direct access to Clermont County talkgroups due to their adjacent location, for the purpose of regular mutual aid.

Other agencies: IF YOU MUTUAL AID INTO CLERMONT COUNTY...

LAW: you'll be directed to use LAW 1,2, or 3 (Zone C) and Dispatch will patch it to the necessary MATAC or incident talkgroup. The other, more direct option is to switch to the assigned SW MATAC 7 or 8 for Clermont found in your Zone E... but follow Dispatch's direction for the proper talkgroup to use.


FIRE: you'll be directed to use SW MATAC 7 or 8, found in Zone D.



Clinton County Joining MARCS IP

Was June 2nd, now June 9th - Clinton County will move to the State of Ohio's MARCS radio system; making them another sibling radio system to

Warren County. They will have SW MATACs in their templates, able to easily mutual aid with us and communicate.



FAQ: Is there a "best way" to charge a portable's battery?

Whatever works best with your shift changes and work schedule. Smart batteries with smart chargers have no

chance of 'frying' or 'boiling over' like the old style battery.

Fire: if you want your shifts to be responsible for their radio life, make it part of changeover for the incoming shift to swap batteries.

Law: Most officers have their own radio/battery, so charge at end of shift. A full charge lasts 8-10 hours.
