

OIBRS DATA ELEMENT #5 "CASE CLEARANCES"

When to use Exceptional Clearance

In order to clear an offense by exceptional means, four conditions have to be met.

- 1. The investigation must have clearly and definitely established the identity of at least one offender
- Sufficient probable cause must have been developed to support the arrest, charging, and prosecution of the suspect
- 3. The exact location of the suspect must be known so that an arrest can be made
- 4. There must be a reason outside the control of law enforcement which prevents the arrest.

The reason an arrest is prevented are the possible entries of Exceptional Clearances: Death of Offender, Prosecution Declined, In Custody of Other Jurisdiction, Victim Refuses to Cooperate and Juvenile/No Custody.

When you are completing your incident report a case clearance must be entered to pass validation. If a case is cleared by arrest and a second offender is later arrested within the same report, a second arrestee segment should be added to the incident but the clearance information does not need to be updated. The state asks that we do not update the information on exceptional clearances.

Last winter, we released a technical bulletin announcing a new ZoneB for law enforcement to include PURSUIT talkgroups and the Lebanon OSP's Dispatch. As the radio team reprograms your department, you'll receive those. Additionally, last month, Telecom & WC Dispatch met with the OSP's Lt. O'Bryan, Dispatch Supervisor Jackson, and ET Shepard to further discuss mutual aiding now that OSP is on the State MARCS IP system.

Plans & Actions Taken: LAW 1,2,3 and their encryption key will be loaded into Post83's dispatcher consoles. Lebanon OSP is also very willing to put the WC interoperability package in their people's radios (TACs, Primaries) which means they can coordinate with both law & fire/EMS

Fire Voice Paging July experienced (2) scheduled outages to tune and troubleshoot the new fire paging program on July 19th and 27th. This took team members at multiple tower sites, a 3rd party vendor, and special engineers. Dispatch helped us by notifying agencies via radio and we also sent emails, HipLink messages, and social media notices.



Creek Caesar Maps In March, Telecom attended a multi-jurisdictional meeting at the state park along with ODNR, US Army Corpse of Engineers, and Coast Guard Auxiliary. One outcome was a request for Park Maps noting the "hot spots", trails waterways to aid first responders. Our mapping guru, Don Sebastianelli, updated the current maps to include missing locations such as the "Horse Beach", the hiking trails (pink), 50 Springs picnic shelter, and the sailboat dry We'll have updated aerials for the Marina this fall. We've since printed 36x36" wall maps for each state & federal agency as well as one for Wayne Twp and Massie Twp Fire.
