We want to communicate to and collaborate with each Department Head's preferred representatives. Targeted emails and notifications will achieve that!

Form Features

- Ability to indicate a partial or full-form submission - if you only need to change one role, no need to fill out the whole form again!
- Administrator—often a Department
 Head's #2 in command. This person can
 also submit the DAF and modify liaisons as your internal staffing and roles change.
- Outage Notice section clearly defines how Telecom will communicate maintenances & outages via email or on our *Coming Soon* Status.io platform. Everyone on this form will be added to our outage email list. To include the rest of your staff, provide a group email that never changes, although the members may from your end.
- Liaisons by specialty Telecom maintains email distribution lists for each liaison group. Our goal is to target communications to the right people who can get system decisions and feedback across the finish line. Don't use a listed system? Just mark N/A and keep going!
- Compared to the previous public safety Agency Authorization Form, this DAF has fewer restrictions on who
 Telecom will interface with from your department. If they're on the form, Telecom assumes they have
 delegated authority to make personnel changes and purchases across all systems. If that's not true for your
 department, delegate internally so your staff know their limits.
- Only one signature field (our previous AA form had 3!)
